Bidding will be conducted through national competitive procurement using a **Request for Quotation (RFQ)** as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Procurement in Investment Project Financing- Goods, Works, Non-Consulting and Consulting Services, November 2020 introduced by the Bank under the Procurement Framework ("Procurement Regulations"), and is open to all eligible Vendors as defined in the Procurement Regulations.

  - 03<sup>rd</sup> Stage Price Evaluation
